The mailing address and the street address of the principal office of the limited liability company is 3020 Bayshore Pointe Dr., Tampa, Florida 33611.

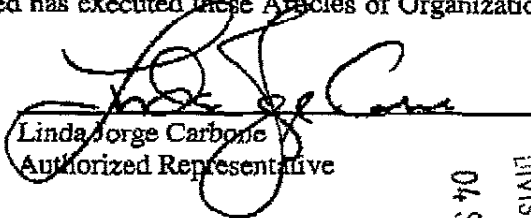
**ARTICLE III

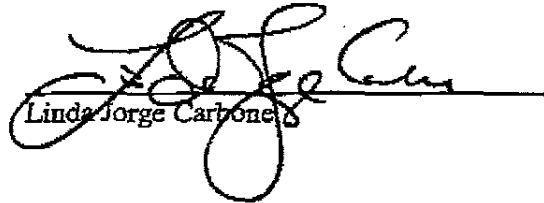
