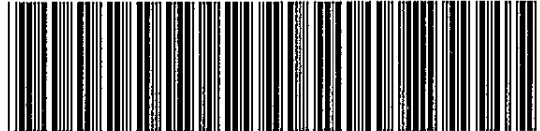


Article 5. Effective Date


