The name of the limited liability company is Powers Place, LLC (the "Company").

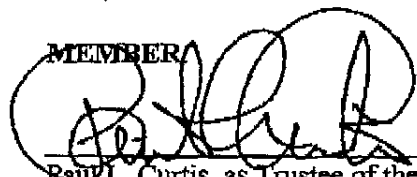
