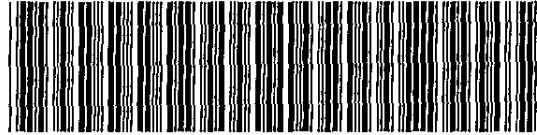

**ARTICLES OF ORGANIZATION OF 10 digits, LLC**

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

**ARTICLE I - Name:**

New members of the Limited Liability Company shall be admitted only upon the consent of all the members or otherwise pursuant to the terms and provisions of its regulations.


**ARTICLE VI - Members' Rights to Continue Business**
