**ARTICLES OF ORGANIZATION
OF
ROTH I, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I
Name

The name of the limited liability company shall be ROTH I, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 10754-2 Scott Mill Road, Jacksonville, Florida 32223.

ARTICLE II
Duration

The Company's existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, company existence shall commence upon filing by the Department of State, and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

ARTICLE III
Purposes and Powers

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.
