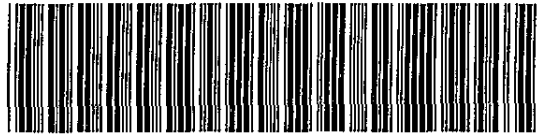

ARTICLES OF ORGANIZATION
OF WOODS ON SIXTEENTH, LLC.
a Florida limited liability company

ARTICLE I

NAME

The name of this limited liability company is WOODS ON SIXTEENTH, LLC

ARTICLE II

PURPOSE

ARTICLE XI
