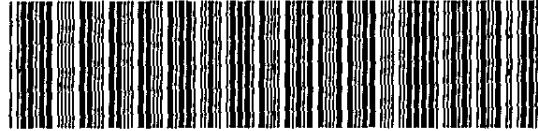

THE UNDERSIGNED, pursuant to the provisions of Chapter 708 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida does set forth the following:

ARTICLE I - NAME

ARTICLE VIII - MANAGEMENT

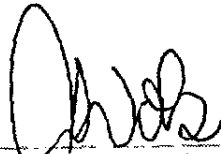

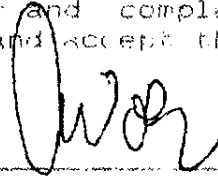
