The Company shall be managed by the Member of the Company as provided in the Company's Operating Agreement.

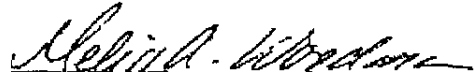

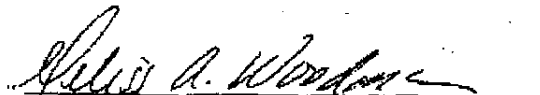
