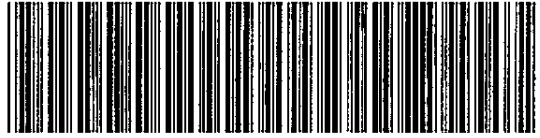

Name. The name of this limited liability company is: **33RD AVENUE NW LLC.**




