ARTICLES OF ORGANIZATION OF GOLD-GATE HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company is GOLD-GATE HOLDINGS, LLC (the "Company").

ARTICLE II DURATION

The period of the Company's duration shall commence on November 23, 2004 and shall be perpetual, unless the Company is dissolved as provided for by law, by these Articles of Organization or in the Regulations ("Regulations") of the Company.
