

ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under and pursuants to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, do hereby? adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Rattlesnake Bend North, LLC (the "Company").

ARTICLE II. ADDRESSES

The mailing address and the street address of the principal office of the Company are the following: c/o Scott A. Saliterman, Diamond Hill Center, 4301 Highway 7, Suite 100, St. Louis Park, Minnesota 55416.

ARTICLE III. DURATION AND CONTINUATION

The period of duration for the Company shall be perpetual, unless terminated in accordance with the Company's Operating Agreement or by the unanimous written agreement of all Members.

ARTICLE IV. REGISTERED AGENT AND OFFICE

The Company designates 417 E. Virginia Street, Suite 1, Tallahassee, FL 32301, as the street address of the initial registered office of the Company and names Capital Connection, Inc. as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE V. MANAGEMENT

The business operations of the Company shall be conducted, carried on, and managed by one (1) Managing Member, who shall be elected annually by the Members of the Company in the manner prescribed by and provided in the Operating Agreement of the Company. The name and address of the initial Manager are as follows: Scott A. Saliterman, Diamond Hill Center, 4301 Highway 7, Suite 100, St. Louis Park, Minnesota 55416.

Each Managing Member shall serve in such capacity until the first annual meeting of the Members or until his successor is duly elected and qualified.

ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.

ARTICLE VII. MEMBERS' RIGHTS TO CONTINUE BUSINESS

The Members shall have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event that terminates the continued membership of a Member in the Company in the manner set forth in the Operating Agreement of the Company.

ARTICLE VIII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
