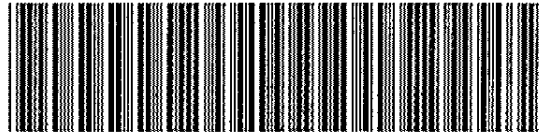



ARTICLES OF ORGANIZATION

1. **Name.** The name of the limited liability company is UGP, LLC.




