ARTICLE III. REGISTERED AGENT



ARTICLE IV. MANAGEMENT

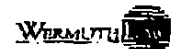
