#### ARTICLES OF ORGANIZATION OF

## HILLSBORO KING'S VILLAGE, LLC a Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

- 1. <u>NAME</u>. The name of the Limited Liability Company is Hillsboro King's Village, LLC (the "Company").
