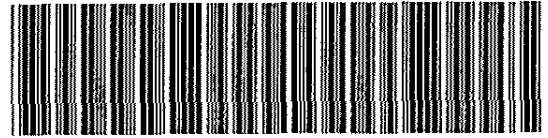

The profits and losses of this Limited Liability Company shall be divided as follows to the managing members of this Limited Liability Company:

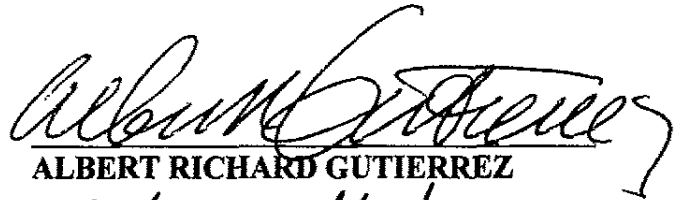

**ARTICLE VIII**

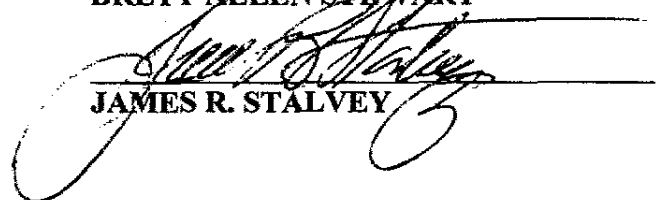

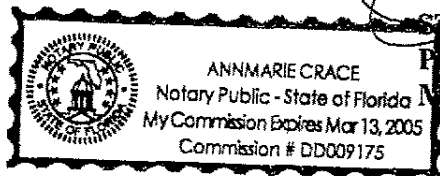

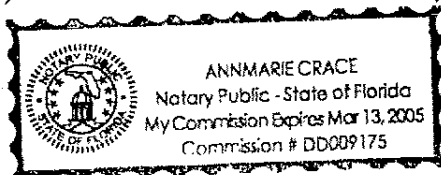
