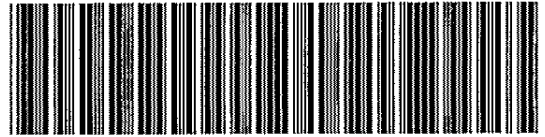


ARTICLES OF AMENDMENT TO
