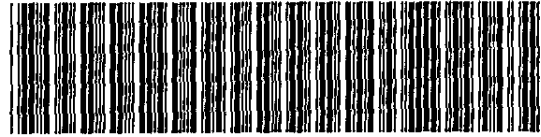

**FIRST AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF  
UNITED AMERICA INVESTMENTS, LLC**

United America Investments, LLC, a Florida limited liability company (the "Company"), hereby adopts this First Amendment to its Articles of Organization pursuant to the provisions of Section 608.411, Florida Statutes:

1. **Name of Company:** The name of the Company is United America Investments, LLC. The Articles of Organization were filed with the Florida Secretary of State on January 12, 2005, and were effective on that date.

2. **Text of Amendment:** The Company's Articles of Organization are hereby amended for the purpose of adding an additional managing member, and that change shall be effectuated by substituting Article VI of the Articles of Organization to read as follows:

**ARTICLE VI  
Management**

This limited liability company shall be a manager-managed company. Initially, the limited liability company shall be managed by Raymond P. Friedman, 15110 Meadowlake Street, Odessa, Florida 33556, and by Janet Christenson, 1790 Main Street, Safety Harbor, Florida 34695, who shall serve as the managing members until their successors are duly elected.

3. **Date of Adoption:** The foregoing Amendment was adopted August 16, 2005.

4. **Manner of Adoption:** The foregoing Amendment was duly approved and authorized by the unanimous written consent of the members of the Company.

5. **Effective Date:** The foregoing Amendment shall be effective upon filing with the Florida Secretary of State.
