ARTICLES OF ORGANIZATION

OF

EVERYTHINGFEET, LLC

The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 608, fiereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **EVERYTHINGFEET**, **LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3185 Southwest 8th Street, Miami, Florida 33135 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE
