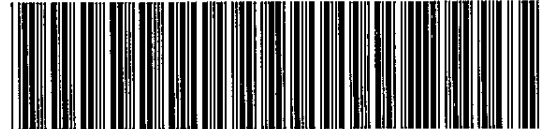

NAME




