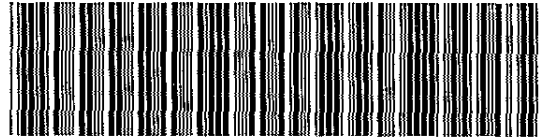

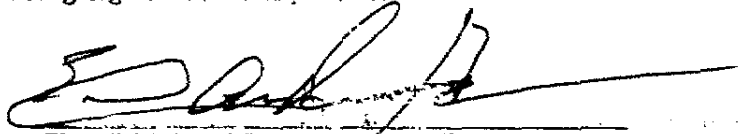
**AGREEMENT FOR SALE OF OWNERSHIP INTEREST
