**ARTICLES OF ORGANIZATION FOR

A FLORIDA LIMITED LIABILITY COMPANY**

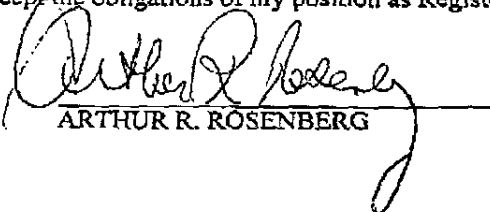
