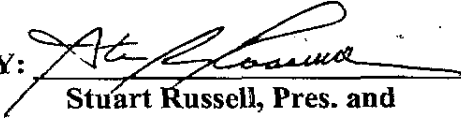
FIRST: The Articles of Organization were filed on February 18, 2005, and assigned document number L05000017102.
