



# ARTICLES OF ORGANIZATION OF FEHR APPRAISALS, LC



ACCURACY PARTY OF STATE OF STA The name of this limited liability company shall be FEHR APPRAISALS, LC, and the mailing address and street address of its principal office shall be 22286 Vick Street.
