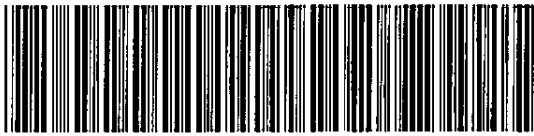



ARTICLE V BUSINESS DEDUCTIONS


