ARTICLES OF ORGANIZATION FOR ANH NGUYEN SALONS, LLC



ARTICLE 1 - Name. The name of the limited liability company shall be Anh Nguyen Salons, LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 4554 13th Street, St. Cloud, Florida 34769.
