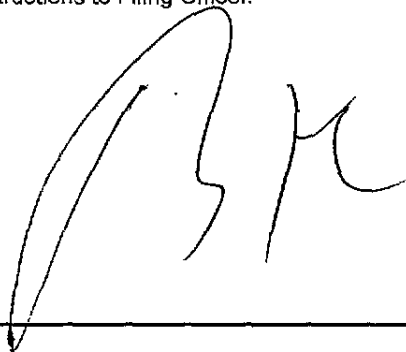

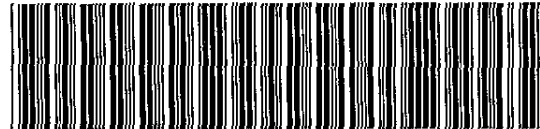

ARTICLE 1-NAME

The name of the limited liability company shall be A.L.D. MANAGEMENT GROUP, LLC.

ARTICLE 2- ADDRESS

The principal place of business of the Company in Florida shall be P.O. Box 450129, Miami, Florida 33245-0129 and the mailing address shall be the same.

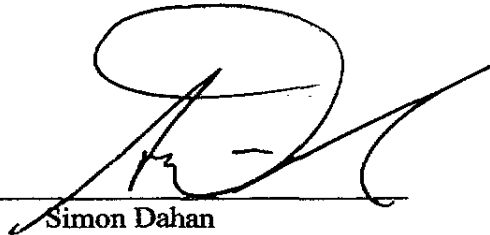

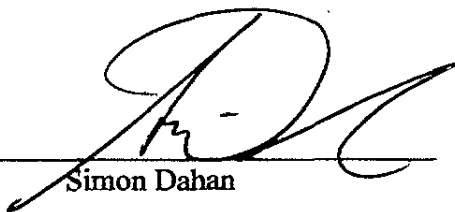

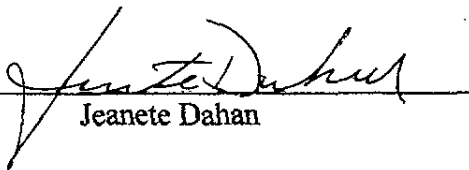
