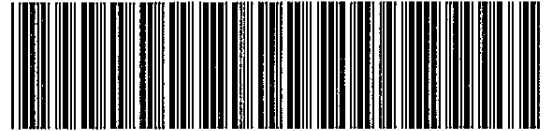

**ARTICLE I - Name**


The name of the Limited Liability Company is RILEA DBD, LLC (the "Company").
