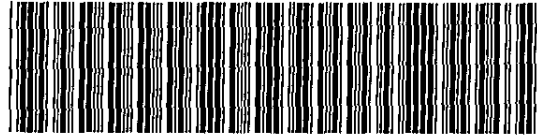

The mailing address and street address of the principal office of the Company is 3750 Planters Creek Circle West, Jacksonville, Florida 32224-7660.

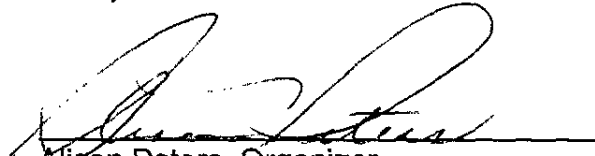
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

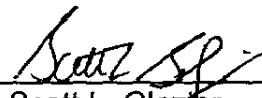
