

## **ARTICLES OF ORGANIZATION**



### FAMILY HOMES, LLC



#### ARTICLE 1 - NAME

The name of the limited liability company shall be FAMILY HOMES, LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 799 Heritage Drive, Weston, Florida 33326-4542 and the mailing address shall be the same.
