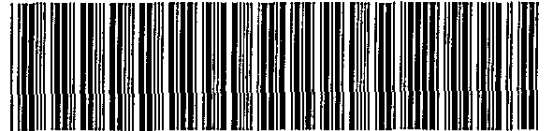



**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

Except as otherwise provided by law, no debt shall be contracted nor liability incurred by or on behalf of this Company except by either of the Managers.


