ARTICLES OF ORGANIZATION
OF

ARTICLE I

to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
