ARTICLES OF ORGANIZATION OF OTALORA HOLDINGS, LLC FLORIDA LIMITED LIABILITY COMPANY

- 1. The name of this limited liability company shall be OTALORA HOLDINGS, LLC (the Company)
- 2. The Company is being formed for the following purposes:

 - •. To do anything and everything necessary, suitable, convenient or

Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgments, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceedings, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or his legal representative may be made a party or may be threatened to be made a party, by reason of his being or having been an officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.
