#### ARTICLES OF ORGANIZATION FOR MARK A. MAKAS, LLC

#### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") acting as the organizer and as the initial member of MARK A. MAKAS, LLC ("Company"), under the Florida Linited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

## ARTICLE I
