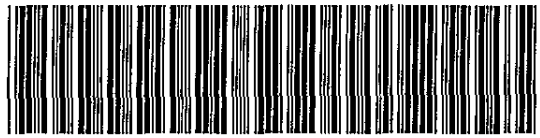

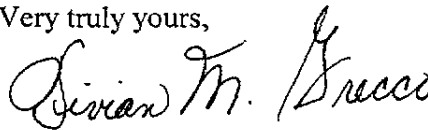

**ARTICLES OF CORRECTION  
TO  
ARTICLES OF ORGANIZATION OF

PURSUANT to the provisions of Section 608.4115, Fla. Stat., this document is being submitted within the required 30 business days to correct the articles of organization filed with the State of Florida on April 11, 2005, and bearing Document Number L05000035518.
