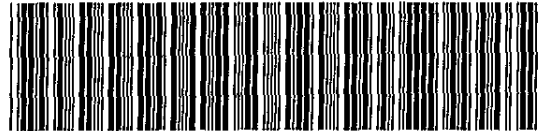

**FIRST AMENDMENT TO THE ARTICLES OF ORGANIZATION  
OF THORNTON COMMONS, LLC**
