## ARTICLES OF ORGANIZATION FOR Avalon Land Management, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

#### ARTICLE I (Name)

The name of the limited liability company is Avalon Land Management, LLC ("the Company").

#### ARTICLE II (Address)

The principal office and street mailing address of the Company will be located at 2208 McIntosh Court, Jacksonville, Florida 32259.

#### ARTICLE III (Duration and Continuation)

The Company shall have perpetual existence, commencing upon April 27, 2005, or such other date no more than five (5) days prior to the filing of these Articles of Organization with the Florida Department of State, whichever is later.

### ARTICLE IV (Purpose)

ARTICLE VI (Additional Members)

Additional members may be admitted as provided in the Operating Agreement of the Company.

#### ARTICLE VII (Members' Rights to Continue Business)
