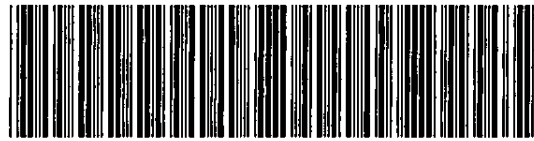

and the word Repair is to be added.


