ARTICLES OF ORGANIZATION

TIMOTHY J. PRUELL, D. The undersigned, for the purpose of forming a limited liability company under the Professional Service Corporations and Limited Liability Companies Act, F.S. Chapter 621, hereby make acknowledge, and file the following Articles of Organization.

The name of the limited liability company shall be TIMOTHY J. PRUETT, DMD, PL ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the professional limited company is 1340 E. Orange Ave., Eustis, FL 32726.

ARTICLE III – PURPOSE

The purpose of the professional limited company is to engage in the practice of dentistry and such other lawful purposes as permitted by Florida Statutes for Professional Service Corporations and Limited Liability Companies.

ARTICLE IV - DURATION

The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE IX - MANAGEMENT

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. These Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
