ARTICLES OF ORGANIZATION OF WC SR 54, LLC

1. NAME. The name of this limited liability company is WC SR 54, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 1315 S. Howard Avenue, Suite 202, Tampa, Florida 33606.
