STACKHOUSE, a natural person competent to contract and an authorized representative of a member of 2-JP, LLC, hereby presents these Articles of Organization as the Articles of Organization of 2-JP, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**
