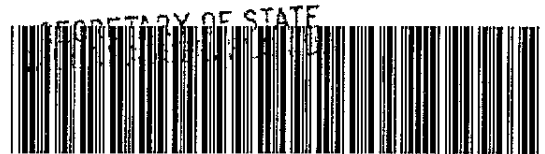

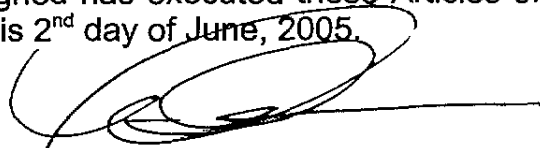
1. Name. ARTICLE I is hereby amended to read as follows:
