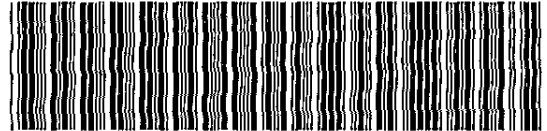

REGISTERED AGENT AND OFFICE

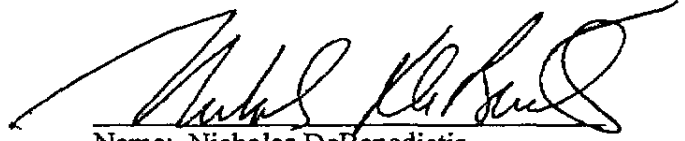
