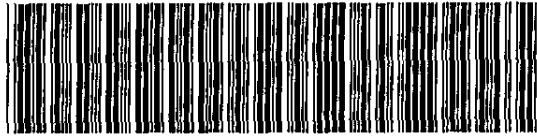

The duration of the Company shall be perpetual, unless sooner dissolved.

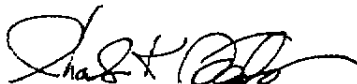
