These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. Name. The name of this limited liability company is **THREE AMIGOS FOUR AT JACKSONVILLE, LLC**
2. Duration. The latest date upon which the limited liability company is to dissolve is January 1, 2043.


