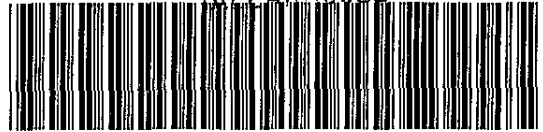



ARTICLE IV - PURPOSES


The Company is organized for the purpose of transacting all lawful activities and businesses.


