# ARTICLES OF ORGANIZATION

OF

#### LOGGIA, LLC

#### A Florida Limited Liability Company

The undersigned hereby certifies these articles have been executed for the purpose of forming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
