# ARTICLES OF ORGANIZATION CALLAHAN TOWNHOMES, LLC

The undersigned, for the purpose of forming a limited liability company for profit under the laws of Florida, adopts the following Articles of Organization:

#### Article 1 <u>Name</u>

Section 1.1. Name. The name of this limited liability company shall be Callahan Townhomes, LLC.

#### **Article II** Principal Office and Mailing Address

#### Article X Amendment

Section 10.1. Amendment. The members, by vote of members holding a majority of the interests in the limited liability company, shall have the right to amend or repeat any provision contained in these Articles of Organization; provided, however, that it shall require a vote of members holding sixty percent (60%) or more of the interests in the limited liability company to amend or repeal Article VIII regarding merger.
