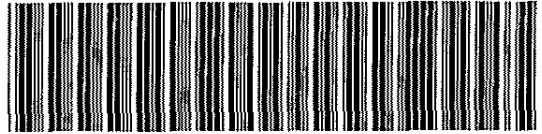


ARTICLE V
