The name of the Company is **ROLO PRODUCTIONS, LLC.**

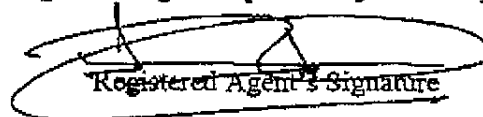

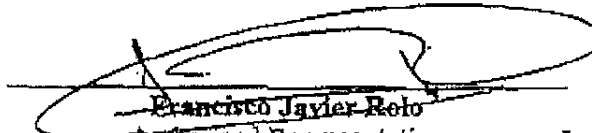
**ARTICLE IV**
