These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Ch. 608, Florida Statutes).

# ARTICLE I

# NAME

The name of this limited liability company is RED BARN PROPERTIES, LLC (the "Company").

# ARTICLE II

# **DURATION**

The Company shall exist from the date of filing these Articles of Organization with the Department of State until the earlier of 50 years from the date of filing or the occurrence of any of any of the events specified in Section 608.441, Florida Statutes (2004), unless continued by the unanimous consent of all of the remaining members.

# ARTICLE III
